We were very pleased to see the proposal to take the cycle way forward. It will be great to have a safe cycle route.

Using the Hinksey Hill roundabout is alarming as a cyclist. It is not safe to cycle due to the large lorries and aggressive car drivers who are impatient to cross the roundabout.

The alternative, using the footpath involves crossing a busy slip road which leads to the A34. There is no pedestrian crossing and no lights to assist when crossing to the footpath. The second crossing has traffic lights but no pedestrian/cyclist crossing. Drivers approaching this junction from the A34 have little to no awareness of anyone crossing. This makes it another dangerous crossing as cars roar up hoping to beat the lights. Lorries often pull over the crossing area waiting for the traffic to clear and have little visibility of anyone trying to cross.

The alternative cycle route will assist in connecting the village and ensuring a safer journey.

Introduction

I am delighted that South Hinksey Parish Council are consulting on the proposal for a new cycle/pedestrian way and I strongly support the objective of improving the route between the Village and Hinksey Hill.

Response

Unfortunately, for the reasons set out below, I do not regard this as a coherent proposal and therefore am unable to support it in its present form.

In particular, while the objective of improving access for pedestrians and cyclists is an excellent one, this proposal does not consider whether the current pedestrian and cycle route could be improved and whether that would be more cost effective.

Please note that the recent improvements to the A34 roundabout at Peartree have included adding traffic light controlled crossings for cyclists and the same approach is part of the planned changes at the A34 Lodge Hill junction. I am surprised the Parish Council's consultation does not consider the option of doing the same for the A34 Hinksey Hill junction.

Main Comments

My professional background is in project management and on that basis my response to this proposal would be to ask for it to be revised to resolve the following points:

- The cost estimate is approximate and unsupported, the only source I'm aware of for the figure of £100k is the comment about "T-shirt" sizing in the report of the Betty Lane Cycleway Working Group, submitted to the Parish Council as paper 4 of its July meeting.
 - T-shirt based cost estimates are normally provided as a range, not a single value, and with supporting argument for the cost being within that range.
- As this proposal was put forward for review in 2004, the obvious question is what has changed in the past 19 years to make it likely that the funds will be raised and that now the project will proceed.
- As noted above, there's no discussion of alternative means of meeting the underlying objective.
- The parish council asserts that the current (frequently used) route is precarious, polluted, busy and in the council's view unsafe. I would expect to see a cost benefit analysis: are the expected improvements worth £100k; if the money can be raised, might there be better uses for it? I don't see how any route which involves crossing the A34 would be less polluted than the current one. I would also expect to see an objective measure of the problems with the current route.

Given those points, I am surprised that a simple support / don't-support response is requested.

Other Points

I note the proposal's statement that the opportunity to consider this project has now arisen. It's not clear from the document why that has happened. The only recent changes I'm aware of are:

- The granting of planning permission for Wren's Hobbit and
- The application of a Stopping-Up order.

Both of those were opposed by the Parish Council.

The submission date for responses is unclear:

- The text on the Parish Council website has no closing date.
- The otherwise almost identical text sent via SHINFO asks for responses by 8th December.

Thanks for circulating information about this initiative. I support it.
